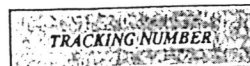
and requested someone to answer the door. At which time movement could be heard inside the apartment. Officer Griffin knocked and announced his presence for approximately 10 minutes; however no one would acknowledge Officer Griffin's request. During that time further movement could be heard inside the location and a small child was heard crying. Officer Griffin and Dowell having reason to believe that one or both of the Defendants were possibly inside the location obtained the key from the Carriage Hill Apartment rental office to gain entry. It should be noted that prior to this occasion Korryn Gaines was identified as the Leasee of the apartment.

At approximately 0920 hrs. Officers Griffin and Dowell accompanied by Officer Kemmerer #5514 opened the door with the key in attempt to gain entry. The Officers discovered an interior chain, locking the door from the inside. Officer Griffin could see partially inside the apartment and observed a Black Female sitting on the dining room floor. The Female was asked to come to the door but refused. Officer Dowell then kicked the door forcing the door open. Officer Griffin entered the Apartment and observed the female holding a Dark in color shotgun. The Female pointed the Dark in color shotgun at Officer Griffin and instructed the Officers to leave. Officer Griffin withdrew from the apartment and called for further back up.

Officer Griffin by his training, knowledge and experience identified the weapon as a possible shotgun.
